# Safety Recall U60 / NHTSA 18V-332 Reprogram Powertrain Control Module

NOTE: Remedy is available for Demon Crate PCM under Safety Recall U83.

<u>NOTE: Safety Recall U60 remedy is only applicable to the original equipment</u> <u>Powertrain Control Module (PCM)</u>.

**Remedy Available** 

2015-2018 (LA) Dodge Challenger 2014-2018 (LD) Dodge Charger 2014-2018 (LX) Chrysler 300

NOTE: Some vehicles may be equipped with a Stage 1 high performance Powertrain Control Module (PCM) part numbers P5160023 and P5160025 intended for use with: 2015 - 2016 (LA) Dodge Challenger, 2014 - 2016 (LD) Dodge Charger, 2014 - 2016 (LX) Chrysler 300 vehicles. In order to complete this Safety Recall U60, the original equipment PCM must be installed in the vehicle then programmed with the latest available software.

*NOTE:* This recall applies only to the above vehicles equipped with a gasoline engine and Cruise Control (Sales Code NHM or NHP or AL4 or NH3) built from May 04, 2013 through May 24, 2018 (*MDH 050423 through 052423*).

**IMPORTANT:** Some of the involved vehicles may be in dealer new vehicle inventory. Federal law requires you to complete this recall service on these vehicles before retail delivery. Dealers should also consider this requirement to apply to used vehicle inventory and should perform this recall on vehicles in for service. Involved vehicles can be determined by using the VIP inquiry process.

## Subject

The fault handling strategy of the Powertrain Control Module (PCM) software on about 865,600 of the above vehicles does not remove positive torque requests from the engine controller if the CAN-C bus stops communicating while the cruise control is requesting positive torque. In the instance of a short in the vehicle causing the CAN-C bus to stop communicating while the cruise control is active and the vehicle speed is below the set speed such that the cruise control system is requesting positive torque at the exact moment of the short, it is possible for a positive torque request to be locked on the PCM which may result in either the vehicle maintaining its current speed or possibly accelerating. If the driver does not shift to neutral or apply the brakes to stop the vehicle this condition can cause a vehicle crash without warning.

### Repair

Inspect the software level of the Powertrain Control Module (PCM) and if necessary, reprogram the PCM.

### Service Procedure

NOTE: Ensure that the original equipment PCM is installed in the vehicle. Do not attempt to complete safety recall U60 using the Demon Crate PCM or Stage 1 high performance PCM or any other high performance PCM.

NOTE: The wiTECH scan tool must be used to perform this recall. The wiTECH software is required to be at the latest release level before performing this procedure. If the reprogramming flash for the PCM is aborted or interrupted, repeat the procedure.

1. Open the hood. Install a battery charger and verify that the charging rate provides 13.0 to 13.5 volts. Do not allow the charger to time out during the flash process. Set the battery charger timer (if so equipped) to continuous charge.

NOTE: Use an accurate stand-alone voltmeter. The battery charger volt meter may not be sufficiently accurate. Voltages outside of the specified range will cause an unsuccessful flash. If voltage reading is too high, apply an electrical load by activating the park or headlamps and/or HVAC blower motor to lower the voltage.

- 2. Connect the wiTECH micro pod II to the vehicle data link connector.
- 3. Place the ignition in the "**RUN**" position.
- 4. Open the wiTECH 2.0 website.
- 5. Enter your "User id" and "Password" and your "Dealer Code", then select "Sign In" at the bottom of the screen. Click "Accept".
- 6. From the "Vehicle Selection" screen, select the vehicle to be updated.

## Service Procedure [Continued]

7. From the "Action Items" screen, select the "Topology" tab.

NOTE: The PCM must be at the latest software calibration level after completing this recall.

- 8. From the "**Topology**" tab, select the "**PCM**" module icon.
- 9. From the "Flash" tab, compare the "Current Electronic Control Unit (ECU) Part Number" with the "New ECU Part Number" listed.
  - If the "Current ECU part Number" is the same as the "New Part Number", proceed to Step 15.
  - If the "Current ECU part Number" is NOT the same as the "New Part Number", continue with Step 10.
- 10. From the PCM tab, select the PCM flash part number. Read the flash special instructions page. Select "**OK**" to continue.
- 11. From the flash ECU agreement page, agree to terms by checking the box.
- 12. Select "Flash ECU" and then follow the wiTECH screen instructions to complete the flash.
- 13. Confirm the software is at the latest available calibration level.
- 14. Click "View DTCs", select "Clear All DTCs", click "Continue" and then click "Close".
- 15. Place the ignition in the "**OFF**" position and then remove the wiTECH micro pod II device from the vehicle.
- 16. Remove the battery charger from the vehicle.
- 17. Close the vehicle hood.

## **Completion Reporting and Reimbursement**

Claims for vehicles that have been serviced must be submitted on the DealerCONNECT Claim Entry Screen located on the Service tab. Claims paid will be used by FCA to record recall service completions and provide dealer payments.

### **Owner Notification and Service Scheduling**

All involved vehicle owners known to FCA are being notified of the service requirement by first class mail. They are requested to schedule appointments for this service with their dealers. A generic copy of the owner letter is attached.

## Vehicle Lists, Global Recall System, VIP and Dealer Follow Up

All involved vehicles have been entered into the DealerCONNECT Global Recall System (GRS) and Vehicle Information Plus (VIP) for dealer inquiry as needed.

GRS provides involved dealers with an <u>updated</u> VIN list of <u>their incomplete</u> vehicles. The owner's name, address and phone number are listed if known. Completed vehicles are removed from GRS within several days of repair claim submission.

To use this system, click on the "Service" tab and then click on "Global Recall System." Your dealer's VIN list for each recall displayed can be sorted by: those vehicles that were unsold at recall launch, those with a phone number, city, zip code, or VIN sequence.

**Dealers** <u>must</u> perform this repair on all unsold vehicles <u>before</u> retail delivery. Dealers should also use the VIN list to follow up with all owners to schedule appointments for this repair.

Recall VIN lists may contain confidential, restricted owner name and address information that was obtained from the Department of Motor Vehicles of various states. Use of this information is permitted for this recall only and is strictly prohibited from all other use.

## **IMPORTANT SAFETY RECALL**

#### **Reprogram Powertrain Control Module**

Dear [Name],

This notice is sent to you in accordance with the National Traffic and Motor Vehicle Safety Act.

FCA has decided that a defect, which relates to motor vehicle safety, exists in certain [2015 through 2018 Model Year Dodge Challenger, 2014 through 2018 Model Year Dodge Charger, 2014 through 2018 Model Year Chrysler 300] vehicles equipped with a gasoline engine and Cruise Control.

It is extremely important to take steps now to repair your vehicle to ensure the safety of you and your passengers.

#### WHY DOES MY VEHICLE NEED REPAIRS?

The fault handling strategy of the Powertrain Control Module (PCM) software on your vehicle <sup>[1]</sup> does not remove positive torque requests from the engine controller if the CAN-C bus stops communicating while the cruise control is requesting positive torque. In the instance of a short in the vehicle causing the CAN-C bus to stop communicating while the cruise control is active and the vehicle speed is below the set speed such that the cruise control system is requesting positive torque at the exact moment of the short, it is possible for a positive torque request to be locked on the PCM which may result in either the vehicle maintaining its current speed or possibly accelerating. **If the driver does not shift to neutral or apply the brakes to stop the vehicle this condition can cause a vehicle crash without warning.** 

#### HOW DO I RESOLVE THIS IMPORTANT SAFETY ISSUE?

FCA will repair your vehicle <sup>[2]</sup> free of charge (parts and labor). To do this, your dealer will inspect the software level of the Powertrain Control Module (PCM) and if necessary, reprogram the PCM. In addition, your dealer will require your vehicle for proper check-in, preparation, and check-out during your visit. Your time is important to us; please be aware that these steps may require more time. The estimated repair time is one hour. We recommend that you schedule a service appointment to minimize your inconvenience. Please bring this letter with you to your dealership.

#### Do not use cruise control on your vehicle until your vehicle has been remedied.

#### WHAT IF I ALREADY PAID TO HAVE THIS REPAIR COMPLETED?

If you have had previous repairs performed and/or already received reimbursement, you may still need to have the recall repair performed.
